**EDUCATOR AND STUDENT MEMBERSHIP:** Educator and Student Members are educators and full-time college students teaching or taking post-secondary education course work in any disciplines related to healthcare facilities management, as determined by the Corporation's Board of Directors. Educator and Student Members may serve on Board committees but may not vote, hold office or serve on the Board of Directors.

**ACTIVE MEMBERSHIP:** Active Members are those individuals who are employed or otherwise engaged by a healthcare provider organization or a medical research facility with a principal place of business in New Hampshire, and who have responsibility for healthcare facility operations. Active Members have full voting rights, and may hold office and serve on the Board of Directors or one of its committees.

**ASSOCIATE MEMBERSHIP:** Associate Members are former Active Members who no longer meet the requirements of Active Membership, but who elect to maintain association with the Corporation. Associate Members may serve on Board committees, but may not vote, hold office or serve on the Board of Directors.

**SUPPORTING MEMBERSHIP:** Manufacturers, vendors, contractors, distributors, service providers, architects, engineers and other professionals who interact with Corporation members as part of their regular business operations. Supporting Members may not vote, hold office or be members of the Corporation's Board of Directors, but they may serve as a non-voting advisory member any of its Committees.

**HONORARY RETIRED MEMBERSHIP:** Honorary Retired Members are individuals with a minimum of five (5) continuous years as an Active Member who have retired from active work in the healthcare facilities field. Honorary Retired Members may serve on Board committees but may not vote, hold office or serve on the Board of Directors.
